

PARENT/GUARDIAN CONSENT FORM
CHILDREN’S ONLINE PRIVACY PROTECTION RULE

St. Hilary School (the “School”) would like to provide your student with the most effective web-based tools and applications for learning both in school and remotely, therefore we must abide by federal regulations that require parental consent as outlined below.

For educational purposes, the School utilizes computer software applications and web-based services operated by third parties including, but not limited to, the following: All Google GSuite for Education Apps, Gradelink, All electronic textbooks, Membean, NewsELA, Zoom, BrainPop, Quill, Follet Shelf – ebooks, Soras – ebooks, Neonet, Class Dojo, Epic!, Seesaw, Spelling City, RazKids, SuperKids, Sumdog, Brainpop, Typing.com, Starfall, ABCya, Edmentum, NWEA MAP, Read Theory, Common Lit, Read Work, Scholastic News, Xtra Math, Kahoot, Quizzizz, Kami, and IXL (hereinafter, collectively “Third Party Sites”).

The privacy policies for the Third Party Sites are available upon emailed request to kheuer@st-hilary.org.

In order for students to use Third Party Sites, certain personal identifying information, generally the student’s name and email address, must be provided to the Third Party Site. Under the Children’s Online Privacy Protection Rule (COPPA), the Third Party Sites must provide parental notification and obtain parental consent before collecting personal information from children under the age of 13. Based on COPPA, the School is permitted to consent to the collection of personal information on behalf of all of its students, thereby eliminating the need for individual parental consent given directly to Third Party Sites.
