

Forest Service Pledges Largest Timber Harvest in 20 Years

In a victory for NAHB, Interim Forest Service Chief Victoria Christiansen told Congress last week that the Forest Service expects its 2018 timber harvest will be the biggest in 20 years.



NAHB has been leading the charge to urge Congress and the Trump administration to consider ways to increase the domestic supply of timber of public lands.

These efforts are especially critical, given that the Commerce Department has placed tariffs averaging more than 20% on Canadian lumber shipments into the U.S. and that the U.S. relies

on Canada to meet roughly one-third of its lumber needs.

Since January of last year, rising lumber prices have increased the cost of an average single-family home by nearly \$9,000. Much of these unprecedented price hikes are due to the lumber tariffs.

Senate Committee on Energy and Natural Resources, Christiansen said: "Our anticipated level of timber harvest in fiscal 2018 is the highest it's been in 20 years. In all, this year the Forest Service plans to







Staying Alive to Run Again

That is what the winners of the primary election now face. The biggest difference is they now face an opponent from the rival party. In many of the primary races, it did not appear the campaigning was against a friend but a foe. But that is politics today. The end goal is to get elected.

With term limits, we saw many contested races, both Democrat and Republican. We now will try to determine just what motivates and is important to the November challengers. Every state office will be occupied by a new officeholder. While the balance of the state legislature will not likely change a lot, many new faces will be in both chambers. Of note, a new House speaker will be elected to serve out the remaining year. The former Speaker resigned in the face of an FBI investigation. The story does not stop there.

Competition to replace him found funding and recruitment of candidates initiated by two hopefuls. The campaigns were not genteel. It seems some bad blood was created which will taint all future activity. That activity has already begun. According to House rules, session may only be called by the Speaker; remember, the Speaker resigned. So, a new speaker muse be elected by the Full House. That requires 50 votes. As I write this neither candidate has 50 votes from the majority caucus. According to some well-placed rumors, a successful candidate may ask some minority members for support.

Just watching history in the making. Now just figuring out how to get HB 371 to the floor amidst all this.

sell 3.4 billion board feet of timber while improving the resiliency and health of more than 3 million acres of National Forest System lands through removal of hazardous fuels and stand treatments."

Christiansen said a major reason why timber harvests are on a pace to run 30% ahead of last year's levels is because of expanded forest management authority in the 2018 omnibus spending bill passed into law last December.

NAHB strongly supported these

provisions in the omnibus bill and continues to work on all fronts to find solutions that will ensure a lasting and stable supply of lumber imports into the U.S. at a competitive price.

RCAC HEARS FROM STAKEHOLDERS ON PROPOSED ENERGY CODE CHANGES

The energy subcommittee of the Residential Construction Advisory Committee (RCAC) met last week to further consider proposed changes to the IECC. Multiple groups presented information on the potential costs and benefits of updates to the energy code currently under review by the committee. OHBA members provided the subcommittee with a very detailed review of the cost of moving ahead with the 2018 IECC, and reiterated how well new homes are being built already under the current code. OHBA discussed the committee's charge in reviewing the codes and the statutory requirements the committee must consider when initiating any code change, which includes the impact on affordable housing. There were also presentations from MEEA and an energy efficiency consulting/design business. The subcommittee will take this information under review before its next meeting on May 23rd at 8:00am where it will likely make a recommendation to the full RCAC.


OHBA MEETS WITH SPONSORS OF WATER/ SEWER EXTENSTION LEGISLATION

Representatives Duffey and Lanese recently introduced HB 602 Water Sewer Service to penalize a municipal corporation for engaging in certain actions related to its provision of water and sewer services outside of its territory by reducing or withholding payments the municipal corporation receives from the Local Government Fund and rendering the municipal corporation ineligible for state water and sewer development funds. Trying to address a concern stemming from the treatment of some surrounding areas around Columbus, the central Ohio legislators assured OHBA it is not their intent to negatively impact residential development. There have been some concerns raised on the legislation's impact on the extension of water and sewer to future developments, and OHBA will continue to engage the sponsors on any potential concern.

HB 371 STILL AWAITING HOUSE VOTE

The House is scheduled to meet only a few more times after the primary this week before they break for summer recess. The legislation modifying the way undeveloped residential property is taxed is still awaiting a vote by the full house. There are many factors to attribute to HB 371 being stalled after an affirmative vote out of committee: local government opposition, a divided caucus, as well as, some lingering misunderstanding on the impacts of the bill. Both the sponsor, Rep. Merrin and OHBA continue to work on getting a floor vote on HB 371, but it is an uphill battle.



APPLYING FOR THE SCHOLARSHIP
