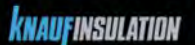

Primary Election Happenings

As all statewide executive offices are up this year for election, you will find a crowded field of candidates to vote for in the primary. In addition, there are a number of candidates for US Congress and Statehouse legislative seats. Only an election can bring out the most outrageous behavior in some. It is very likely you will witness some of this behavior now as early voting as begun. When the primary election is over and the winners declared, you get to hear and see it all again in the general election in November. Lucky us huh!

Nonetheless, those elected will be running the state government for the next two years. History proves primary elections have a tendency for nominating the most politically positioned candidates for their respective party; in other words, they are extreme. This applies to both political parties. To the winners goes the spoils. Many around here think political fortunes may change this year.

Naturally, most will hedge their bets by backing both candidates.

We will get a glimpse of chances of success in November as the primary winners are declared. In the meantime, we can only hunker down and hope for the best. ■

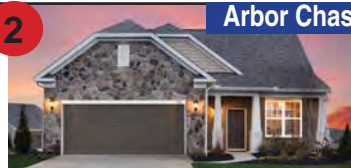

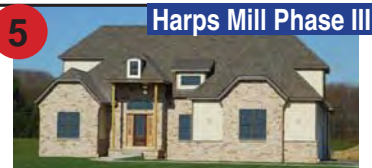

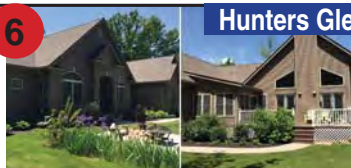

HB 371 REMAINS STALLED IN HOUSE WAITING FOR VOTE

OHBA continues to talk to all members of the House on HB 371 and its impact on housing and development, especially in those areas where there has not been any recent development. OHBA has explained away numerous reasons for potential opposition ranging from the argument that no tax will be collected to a developer using this exemption to get rich. Many of the members of the House continue to hear from their country auditors and local government officials on the negative impacts HB 371 will have if it's passed.

OHBA encourages anyone interested in HB 371 to contact their representatives and county auditors to help explain the real impact of changes proposed in the legislation.

The House will take a short break before the May primary, but is expected to come back for a few session days in May before the summer recess.

OEPA STORMWATER DISCHARGE GENERAL CONSTRUCTION PERMIT (GCP) UPDATE

After receiving numerous comments on the proposed changes to the GCP, the OEPA is holding a meeting today to explain further changes the agency has made in response to stakeholder

comments. OHBA led a coalition of industry groups in submitting a letter with significant changes to be made to the proposal. The current permit expires April 20th, and it is likely the OEPA will move forward with the final permit after explaining the most recent modifications. Among other changes, OHBA and coalition members requested removing the electronic submittal requirements for SWPPP documents, concerns with inclusion of specific watershed permits within the general permit, and the requirement for assurance of perpetual maintenance of post construction practices as a condition of permit approval. OHBA will continue to provide an update on the status of this permit as it moves ahead.

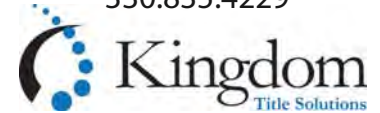
