There are numerous Biblical passages that refer to the importance of a single stone in building a foundation. In some cases, the references are to the Rock, or Cornerstone: Christ himself. In other cases, the implication is that each of us is a stone, a living, breathing stone, which can be joined with others to establish a solid foundation to do God's work. It is these living, breathing stones from which the St. Hilary Parish Foundation derives its strength and sets about the work of ensuring a vibrant future for our parish and school.

Provide Support

One of the newest and largest efforts of the St. Hilary Parish Foundation toward sustainability into the future is its massive scholarship initiative, rolled out for the 2016-2017 school year. This annual initiative has already provided 46 scholarships totaling \$70,500 in just its first two years, and is poised to offer another 21 scholarships totaling \$30,250 for the 2018-2019 school year. These scholarships would not be possible without the generosity of living stones - donors - who believe in the importance of establishing a foundation upon which our children, our school, and our parish can grow. Scholarships offered through the St. Hilary Parish Foundation include the Friend of St. Hilary Scholarship, the Mother Teresa Scholarship,

the Sr. Carol Joy Scholarship, the St. Aloysius Scholarship, the St. Hilary R.E.D. Scholarship, the Striving Saber Scholarship, the Ralph and Florence Bernard Scholarship, the Rev. Steven Brunovsky Catholic Leadership Scholarship, the Edward L. Gilbert Family Scholarship, the St. Hilary Knights of Columbus Scholarship, the St. Hilary Parish Foundation Tuition Assistance Scholarship, the Kevin Neff Memorial Scholarship, the Jane Klenotic Scholarship, the Jimmy Lyons Geography Bee Scholarship, and the St. Hilary Athletic Association Scholarship. While the Athletic Association Scholarship supports eighth grade recipients' high school tuition, each of the other scholarships is applied directly to awardees' St. Hilary School tuition. Some of these scholarships offer awards to multiple students each school year.

Impact Lives

The majority of the scholarships are issued confidentially due to financial considerations that factor into their awarding. For the students and families who receive these generous gifts of assistance, the scholarships often mean the difference between being able to continue a St. Hilary School education and needing to look for another option. Some of the scholarships supported by the St. Hilary Parish Foundation and its donors are awarded without the students or families applying for them, simply because the recipients are recognized as bearing qualities reminiscent

of the individuals the scholarships memorialize. The Kevin Neff Memorial Scholarship and the Jane Klenotic Scholarship are two of these. The Neff Scholarship honors St. Hilary School graduate Kevin Neff, who died of a brain tumor while in high school. The Klenotic Scholarship honors long-time St. Hilary School second grade teacher Jane Klenotic, who lost her battle with cancer several years ago. The Kevin Neff Memorial Scholarship is awarded each spring to a seventh grader at the school who embodies the characteristics Kevin displayed during his life. The Jane Klenotic Scholarship is given annually to a second grader who represents the attributes Jane stood for in her own life and fostered in her students.

In the 2016-2017 school year, the Kevin Neff Memorial Scholarship was awarded to not just one, but three seventh graders who displayed the qualities of Kevin Neff: siblings Jackson, Max and Rachel Alexander.

DIRECTOR'S MESSAGE:

I continue to be humbled by the generosity of the donors who support the St. Hilary Parish Foundation. Each and every donation makes a difference, just like each stone in the foundation of a building makes a difference. If

you were to pull away any one of the stones, it would affect the foundation, causing it to not be as secure. Such is the case at the St. Hilary Parish Foundation. 


A Foundation grant of nearly \$53,000 funded paint and acoustical treatment updates in the Church.

Through the generosity of many "precious stones", as well as the commitment of the Foundation's Board of Trustees, which oversees the distribution of grants and the management of our funds with investment policies that

have fostered prudent and steady growth, the Foundation has been able to grow to \$8.5 million. In return, this year, the Foundation was able to grant funds of just under \$253,800 for capital and operating needs of St. Hilary Church and School. Of that amount, a grant of \$52,680 was awarded for the painting and acoustical treatment in the church, \$97,980 was granted for replacement of the section of roof over the Koegel Spiritual Center, \$8,870 was awarded to upgrade the church audio equipment, \$8,206 was given for evangelization and religious vocations, and \$6,550 was awarded for equipment and church technology. In addition, grants of approximately \$82,512 were given for scholarships and tuition assistance for St. Hilary School students, as well as programs, equipment and technology for the school. (Details of the distributions to the school can be found within this report.) Looking at the host of needs supported by the Foundation just this year alone, you can see why each of the Foundation's donors is such a "precious stone". Were it not for their generosity through the funds established with the Foundation, funding for items such as these would have to come from donations overtly requested of parishioners from the pulpit. The St. Hilary Parish Foundation truly is a key component of the fiscal foundation of our parish and school.

As we to look to the future, even more "precious stones" are needed to continue to build a solid Foundation so that the many needs of our St. Hilary Parish and School community can be addressed. Our focus for the future is to continue to grow our unrestricted, tuition assistance and scholarship funds to enable the Foundation to distribute larger amounts to meet the needs of our church and school. I ask you to prayerfully consider a gift to one of our many designated funds or to establish a family named fund to address a need within the St. Hilary \$98,000. community that is important to you.

A SOLID FOUNDATION



PASTOR'S MESSAGE:

One of the most impressive buildings in Washington D.C is the National Cathedral of the Episcopal Diocese. This cathedral is built like the cathedrals of old, without any structural steel or modern methods. Stone carvers continue to make repairs and replacements using old fashioned techniques perfected by the carving guilds of the Middle

Ages. If you tour the cathedral, you can walk into the cross aisle, where the side naves join the main nave in the form of a Latin cross. Looking up, you can follow the soaring line of the four large stone pillars at the corners of the cross aisle as they ascend higher and higher, becoming increasingly thinner as they rise. If you were able to see beyond the ceiling, you could observe those four pillars as they taper to decorative finials high above the roof line!

But what about below? What happens to those pillars beneath the floor of the cathedral? You can begin to see them when you descend to the crypt level of the church. Those four pillars are massive and can be observed as the rounded walls of the crypt chapel. Ask a guide and they will tell you that those four pillars continue to expand even deeper beneath the level of the crypt, until they touch one another resting upon solid bedrock! This image of the solid foundation of stone upon which the National Cathedral is build is also an apt image for the St. Hilary Parish Foundation! This is so first of all because the Foundation was started by our first pastor, Father Edward Horning, and a group of foresighted parishioners 41 years ago and represents the generosity of many faithful parishioners who were founding members. They are the bedrock upon which this parish community stands. Their vision and decisions are still reaping benefits as we approach our parish's 60th anniversary next year. Secondly, their decision to begin saving money for future needs, even though the present needs were very pressing, provided a model for our future stewardship. Over the years, parishioners have generously donated to the St. Hilary Parish Foundation knowing that these funds would be wisely invested, and would remain in perpetuity, continuing to provide financial support for many years to come.

Because of this solid Foundation, we have been able to complete a variety of projects in the past few years that would have necessitated either several second collections or capital campaigns. But because the St. Hilary Parish Foundation is fiscally sound, those needed monies were already available! Think about that the next time you are driving on our new parking lot, looking at the newly painted church interior, or sitting in a meeting in the Spiritual Center without water dripping on your head, thanks to the new roof! The Foundation also provides the building blocks for Catholic education



Note: Blue-tinted panels in graphic below indicate committed panels Actual crystal panels are clear, with beveled edges and etched type.




a difference and secure the viability of our parish school for many years to come.

FOUNDATION SUPPORTS SCHOOL STONE BY STONE

Providing students with an excellent Catholic education requires extensive resources. Thankfully, the St. Hilary Parish Foundation has been able to support the school for more than four decades through the generosity of its donors, the living stones that buttress the St. Hilary community. In 2017, the Foundation funded several schoolrelated items that directly impacted students. The Foundation provided \$25,000 in funds to supplement the more than \$150,000 the Parish already commits to tuition assistance each year. This generous gift directly aided 83 students who might otherwise not have been able to attend St. Hilary School during the 2017-2018 school year.

Assisting Students Through Scholarships

Next month, the Foundation will offer for the third year its cadre of scholarships for which students returning to the school in 2018-2019 may apply. Introduced in December 2015, the Foundation thus far has awarded a total of 34 scholarships totaling \$60,500, with 15 of those, totaling \$25,500, being awarded in 2017. These scholarships provide funds to students who are selected based on meeting the criteria established by the scholarship donors. They include the Friend of St. Hilary Scholarship, the Mother Teresa Scholarship, the Sr. Carol Joy Scholarship, the St. Aloysius Scholarship, the St. Hilary R.E.D. Scholarship, the Striving Saber Scholarship, the Ralph and Florence Bernard Scholarship, the Rev. Steven Brunovsky Catholic Leadership

Scholarship, the Edward L. Gilbert Family Scholarship, and the St. Hilary Foundation Tuition Assistance Scholarship. Names of the students who receive these scholarships are not published in order to protect the privacy of their families, as many of these scholarships are based on financial need.

Providing Amenities for Students

The Foundation funded over \$22,000 in amenities and equipment for St. Hilary School students and staff in 2017. The majority of these funds were used to purchase 1:1 Google Chromebooks for the school's sixth grade class, and to renovate the school website. Also purchased was a scrubbing machine to assist with efficiently and properly maintaining the new floor in the school Multi-Purpose Room. Because the room is used for lunch and other events and programs on a daily basis, keeping the floor clean is essential. Programming and professional development were also provided for the school faculty and staff, notably including programming addressing the needs of students with autism. Finally, the Foundation purchased a media player for the school's music classes. The Foundation is committed to ensuring St. Hilary School students have a safe, sound environment in which to learn, amenities to enhance their education, and teachers who receive ongoing professional training. As the school building and the equipment it houses continue to age, maintenance, repair and replacement are all within the Foundation's funding purview for years to come. Additionally, the Foundation is aware of the vital importance of professional development programming to keep the school's faculty and staff versed in best educational practices. The scholarships mentioned here complement the Kevin Thomas Neff Memorial Scholarship, the Jane Klenotic Scholarship, the Jimmy Lyons Geography
Bee Scholarship, and the St. Hilary Athletic
Association Scholarship. Through the Kevin
Thomas Neff Memorial Scholarship Fund, the
Foundation annually awards a \$1,250 Kevin Neff
Memorial Scholarship, which because the memory of Memorial Scholarship, which honors the memory of deceased St. Hilary School alumnus Kevin Neff, to a St. Hilary School seventh grader who exemplifies the ideals Kevin aspired to during his life. The Jane Klenotic Scholarship Fund enables the Foundation to provide a \$1,000 award to a second grader who has the attributes of spiritual, academic and personal character that were important to Jane Klenotic, who taught second grade at the School until she lost her battle with cancer.

The Jimmy Lyons Geography Bee Scholarship Fund was begun in memory of St. Hilary School 2006 graduate Jimmy Lyons, who won the School's geography bee for four consecutive years between 2003 and 2006, was a state bee competitor, and passed away in 2011. This \$500 scholarship is awarded to the winner of the School's geography bee each year, going to Christian Parker in January 2017.

Additionally, two \$500 St. Hilary Athletic Association scholarships are awarded through the Foundation each year to two St. Hilary School eighth grade student athletes who have participated in at least two St. Hilary athletic programs during their eighth grade school year, achieved first or second academic honors during the first, second, and third quarters of their eighth grade year, and third quarters of their eighth grade year, demonstrate good conduct and sportsmanship on and off the field of play, demonstrate and model Catholic values and morals, and are continuing their education at a Catholic high school. The scholarships are applied to the recipients' high school tuition. In May 2017, Regina Demechko and Nathan Lahovich received these scholarships. With the retirement of the recently deceased Ed Carter last year after 30 years as St. Hilary Parish Foundation President, longserving Foundation Board member Frederick Lombardi has taken on the leadership of this essential entity that does so much to support our parish and school. Lombardi, a trustee and founding

member of the Foundation, has been a member of the parish since 1966. Most recently serving as the Board's Vice-President, Lombardi has also served in other leadership roles on the St. Hilary campus, including as chairman for the committee for the formation of the St. Hilary Parish Council and subsequently as the Council's first President, and as a former chairman and member of the St. Hilary School Board. Now, after election as the St. Hilary Parish Foundation Board President, Lombardi has his sights set on the future.

Continuing a Legacy

Saying he is "proud and happy to serve as President," Lombardi is focused on making sure the Foundation can continue to support the capital needs of the parish and school for years to come. He has been an integral part of the Foundation's growth from inception, and knows its value to the St. Hilary community. Working alongside Fr. Edward Horning, the founding pastor of St. Hilary Parish, Lombardi and Joseph Lechiara were members of the Foundation's original Board of Trustees, along with its first President, Charles Pilliod, Vice-President Mario DiFederico, Ed Carter, Benedict Presper, William Richards, Jr., and Fr. Horning. Lechiara served as the Board's first Secretary/Treasurer. Beginning with \$200,000, these individuals set in motion the wheels for the sound decision-making that still guides the Foundation in its investing and giving of funds today. Lombardi encourages individuals to establish funds with the Foundation and direct their donations toward needs that are important to them, such as unrestricted funds, scholarships, tuition assistance, or any of a host of other needs of the parish and school. Like the late Ed Carter, Lombardi champions the goal that the Foundation will be able to help keep school tuition low and affordable for all families seeking a St. Hilary School education. Lombardi appreciates the worth of a St. Hilary School education, as his four sons with his wife Margaret all attended the school.

Besides his dedication to his parish and its school, Lombardi has also served in numerous capacities with various community and educational institutions. An attorney and shareholder at Buckingham, Doolittle & Burroughs, LLP, where he has been practicing law since 1962, Lombardi also serves on the board of the Summa Health System Foundation and is a former trustee of the Downtown

Akron Partnership. He is a lifetime trustee of Akron Golf Charities, Inc., past chairman and trustee of the World Series of Golf, past trustee and vice-president of the Ohio Ballet, past trustee of Walsh Jesuit High School, chair of the Attorneys Division of the United Way campaign in 1998, and served as the President of the Akron Bar Association from 1998 to 1999. Also a graduate of the Leadership Akron N.E.X.T. Program (New Endeavors for Experienced Talent) Class II, a community-oriented program for senior leaders, Lombardi is listed in "Who's Who in America" and "Who's Who in American Law" and was also named an Ohio Super Lawyer from 2004 through 2008. He has been listed in Best Lawyers in America since 2010, including being named as Lawyer of the Year for Akron Banking and Finance Law in 2015 and as Lawyer of the Year for Akron Litigation -Real Estate in 2014. With such an accomplished and vested leader at the helm of the Foundation, St. Hilary Parish and St. Hilary School can be assured that their best interests and viability are being safeguarded well into the future.
