## **Foundation Marks 30 Years**

Celebrating Success, Mourning Loss, Looking Ahead

More than 30 years ago, Fr. Edward Horning, founding pastor of St. Hilary Parish, had a vision. "Fr. Horning had great foresight. He found a way to set money aside, recognizing the future needs of the church and school,"



according to Ed Carter, St. Hilary Parish Foundation President. Sparked by a need to meet the future financial requirements of a growing parish community without tapping into offertory collections, the St. Hilary Parish Foundation was founded in 1976.

Carter, current Foundation Board Member Fred Lombardi, and the late Bill Richards worked together to set up the fledgling entity. Carter recalls Bishop Pilla being so impressed by the manner in which the Foundation was established that he asked Carter and his co-founders to meet with leaders at other parishes in the Cleveland Diocese. The hope was that the Foundation could serve as a model for the establishment of other parish foundations.

Today, eight individuals, including Fr. Yahner, comprise the Foundation's Board of Trustees. Carter notes that the Foundation is headed by a bright group of people who keep a watchful eye on the Foundation's investments.

Over the years, the Foundation has made numerous grants to assist with church and school needs. Notable, according to Carter, were the \$250,000 given as a catalyst for construction of the spiritual center

under Fr. Koegel, the \$450,000 given to jump-start the parish capital campaign under Fr. Yahner, and an additional \$500,000 given to match funds raised by the parish under Fr. Yahner.

From a meager beginning, Foundation funds have grown to their current value of over \$1.7 million. Carter says the goal of the Foundation is to increase funds to about \$3 million, which will allow the Foundation to "take care of St. Hilary into the distant future." He stressed the importance of parishioners recognizing their blessings and supporting the Foundation. "We all need to be thinking about St. Hilary 10 to 20 years from now. We need to look toward maintaining a vibrant church and school. If St. Hilary has been good to you, give back," he says.

## Did You Know...

- The St. Hilary Parish Foundation is 30 years old.
- Fr. Horning and the original contributors established the Foundation with \$400,000 in seed money or pledges. Today, the Foundation's endowment funds total more than \$1.7 million.
- In 1983, the Foundation made its first gift to the parish. Just over \$30,000 was spent to replace and repair the church roof and the parking lot.
- The St. Hilary Parish Foundation News is a twice-yearly publication of the Foundation, not the parish itself. No parish funds, no offertory funds and no school funds are used to produce or mail this newsletter.
- A devoted, volunteer board of trustees oversees the foundation endowments, investments and spending. Six parishioners and the pastor sit on the board of trustees.

## Director's Message

"Taste and see the goodness of the Lord; the goodness of the Lord." Sometimes we hear that responsorial psalm at Mass and sing it by rote. But thinking about those words makes me think about the ways our Lord has been good to the St. Hilary Parish Foundation.

For 30 years this Foundation has served our church and school, and in that time the Foundation has grown strong and successful. That achievement is a blessing.

From Fr. Horning's straightforward concept of a Foundation to supplement the needs of a growing parish, the Foundation has grown to 20 different funds. The Foundation was created with some of Fr. Horning's own money and initial contributions or pledges totaling \$400,000. Now the funds total more than \$1.7 million.

Foundation money is separate from the offertory collection and the parish budget. The Foundation does not receive funding from tuition or the school Parents' Association or other parish ministries. All Foundation funds come from donors, benefactors and interest on investment of the capital.

Early on, the Foundation trustees permitted only a percentage of the interest on the Unrestricted Endowment Fund to be spent, investing the principal for long-term growth. But when the Fund reached \$1 million, the trustees were willing and able to use the entire interest income to help the church and the school.

The Foundation considers many requests each year from the church and the school. This past year, the Foundation was able to distribute \$42,000, and trustees were pleased to use it to improve and upgrade the acoustics in Horning Hall and to repair the school roof. In addition, \$7,100 was distributed from designated funds such as the Kevin Thomas Neff Scholarship Fund, Multi-Child Tuition Assistance Fund and Sandy Carlson Scholarship Fund, for scholarships and tuition assistance for qualifying St. Hilary students. In so many ways, the Lord has been good to the Foundation and the Foundation has been good to, and for, the Parish.

As the Foundation celebrates 30 years of service to St. Hilary Church and School, it would be easy to nod approval and think about other things. Instead, I prefer to see and honor all the ways the Foundation has been enriched by the "goodness of the Lord."

## Matthew Schwenning Receives Neff Memorial Scholarship, Carries on Legacy

When 16-year-old Kevin Neff died of an inoperable brain tumor in 2003, Fr. Jim King issued a challenge to those attending Kevin's funeral. "What are you going to do about Kevin's death? What are you going to do about his unfinished masterpiece? ... Can you build on his courage, his faith, his unrealized dreams?"

Kevin, a 2000 St. Hilary School graduate, was a junior at Walsh Jesuit High School at the time of his death. Today, his legacy lives on in Matthew Schwenning, this year's recipient of the St. Hilary Parish Foundation scholarship named in Kevin's honor. Matthew, the son of Mark and Jean Schwenning of Richfield, will be an eighth grade student at St. Hilary School in the fall. The \$500 award will be applied to Matthew's tuition.

The Kevin Thomas Neff Memorial Scholarship was established to recognize one St. Hilary student each year who exemplifies the characteristics Kevin demonstrated during his short life. The student selected for the award must meet certain academic, spiritual and social criteria. In awarding the scholarship, St. Hilary School Principal Dr. Patricia Nugent noted many parallels between the lives of Matthew and Kevin.

Dr. Nugent presented the scholarship at the school's May Crowning Mass on May 17. Kevin's mother, Peggy Neff, said her family requested that the scholarship be awarded at the May Crowning Mass each year, in tribute to Kevin's deep devotion to the Blessed Mother.

Dr. Nugent stated that it is "very important that the good Kevin did on earth be continued, and that he continue to touch lives." Kevin's father, Mike Neff, estimates that the lives Kevin touched number in the tens of thousands. By all accounts, Matthew Schwenning was this year's obvious choice to continue Kevin's good work.

Matthew is an honor roll student

who recently performed in the school musical, Oklahoma!, and loves math and computers. His mother, Jean Schwenning, noted that Matthew has worked very hard to earn and retain membership in his advanced math class. His father, Mark Schwenning, added that his son has a logical mind and a knack for troubleshooting. "He's the one the teachers always call on when they need help with the computers at school," Mr. Schwenning said.

Matthew plans to attend high school at either St. Vincent-St. Mary or Walsh Jesuit. He is not yet leaning toward any particular college, but intends to pursue a career in network programming.

Currently a Star Boy Scout, Matthew will earn his Life Scout rank this summer. That will put him only one rank away from becoming an Eagle Scout. Mrs. Schwenning characterizes her son as kind and helpful and says he is surrounded by many friends. Mr. Schwenning said, "Matthew thinks way beyond what you'd expect him to be thinking. He wants to do things above and beyond what most people would do."

Mrs. Schwenning described the presentation of the scholarship award to Matthew as a "bittersweet moment." She said her family is honored that Matthew was chosen to carry on Kevin's legacy.

Matthew's name will join that of last year's recipient, Nancy Joyce, on a plaque that hangs in the school foyer.

## Horning Hall Acoustic Treatment Improves Sound Quality

Teaching physical education at St. Hilary School used to be a complicated affair for Tami Stamets. "I would have to literally stop whatever activity I was doing with the students, and pull them all close to me in the center of the floor so they could hear my instructions," said Mrs. Stamets, who teaches physical education to roughly 700 St. Hilary students. "It was extremely frustrating." Poor acoustics in the Horning Hall gymnasium caused an echo that made it difficult for students to hear clearly. Mrs. Stamets daily strained her voice trying to communicate verbal cues to her students. "It really limited what I could teach," she said.

With the help of St. Hilary School parent Mark Schwenning and the St. Hilary Parish Foundation, the gym now boasts acoustic treatment that has vastly improved sound quality. Mr. Schwenning, a telecommunications engineer who is passionate about physics and acoustics, oversaw the project, of which just over \$29,000 was underwritten by the Foundation.

Mr. Schwenning described the problem behind the poor sound quality as a high "reverb time."
"The problem wasn't with volume," said Mr. Schwenning. "It was a problem of sound and speech intelligibility. You couldn't understand what was being said. You would hear the same sound again and again."

Mr. Schwenning collaborated with two acoustical consultants to conduct tests in the gym and determine how to best treat the acoustic problem. M.B.I., a Cleveland company that specializes in acoustic treatment, installed special panels on the walls and in the ceiling of the gym. The project was completed over four days at the end of December, 2005, while the school was closed for Christmas break.

Four-foot-square, two-inch-thick fiberglass panels were covered with special cloth and applied to the walls. Four-inch thick fiberglass panels measuring four feet by 20 feet, and covered with rip-stop nylon, were installed in the ceiling. According to

Mr. Schwenning, the ceiling panels "do most of the work." The "reverb time" in the gym has been reduced to an acceptable level, and sound quality improves further when people are in the room.

The formerly poor acoustic conditions in the gym also caused problems during school assemblies and performances. LuAnne Toth, St. Hilary School music teacher and choir director, and Marilyn Miller, St. Hilary School librarian and drama club adviser, produce the school's spring musical performances each year. Mrs. Toth also directs other

musical performances in the gym during the school year. They commented that the garbled sound made it difficult for student performers to be heard clearly, especially in the back of the gym. The two recently oversaw the school production of *Oklahoma!*, and found that there is a noticeable improvement in sound quality, thanks to the new acoustic treatment.

Mrs. Stamets said the treatment has made a world of difference both in what she can teach and in students' behavior, because they can now clearly understand her instructions. "It is such an improvement," she said. "I am just so grateful, because it has made my job much more enjoyable, and the kids get more out of my classes now."

## Two St. Hilary Graduates Receive Carlson Scholarships

"See the good in everyone you meet, be a compassionate friend, and always take time to share laughter."

A simple philosophy, these were the words by which former St. Hilary faculty member Sandy Carlson lived. Miss Carlson died in 2004, but her legacy continues via a scholarship bearing her name. The Sandra Lee Carlson Scholarship Fund is part of the St. Hilary Parish Foundation family of funds.

Miss Carlson wanted to award scholarships to graduating St. Hilary eighth graders to assist with their Catholic high school tuition. Donations the Foundation received following her death were earmarked for the Carlson Scholarship Fund, from which the first scholarships were awarded last spring.

To qualify for a Carlson scholarship, an applicant must be a St. Hilary eighth grader accepted at a Catholic high school in the Cleveland diocese. Applicants must have an A or B average in all major academic areas, and must exhibit good conduct, leadership skills, and Catholic values and morals. They must also answer in writing three questions: What is your simple philosophy? How can this impact

your life and the lives of others you meet? How has your Catholic education helped you to develop this

simple philosophy?

This year, St. Hilary School Principal Dr. Patricia Nugent presented Carlson scholarships to two St. Hilary graduates. The \$500 scholarships were announced at the eighth grade awards luncheon held on May 31.

The recipients of this year's Carlson scholarships are Sara Felden and Jennifer Semans. Sara is the daughter of Rob and Joanne Felden. Jennifer is the daughter of Tom and

JoAnn Semans. Both girls will attend Archbishop Hoban High School in the fall, and their awards will be applied to their tuition.

Carter also spoke of the recent loss of founding member Bill Richards, who he described as "a topnotch businessman and a person with a wonderful Catholic attitude." Richards had filled various roles on the Foundation, including heading the finance committee, overseeing promotional activities and, most recently, serving as Vice President. "He was a great friend," Carter said, "and his loss is a real loss to the Foundation." Carter said the Board of Trustees has voted not to fill Richards' seat at this time.

The plaque features a photo of Kevin, and the inscription, "Strength and Honor." Kevin drew the motto from his Latin classes at Walsh, and based his life on it.

Following the awarding of the scholarship, the Neff family presented Matthew with a music box from Lourdes, France, where Kevin visited the renowned shrine before his death. Mrs. Neff said the music box plays Ave Maria and contains a rosary. She said the family also gave Matthew WWJD (What Would Jesus Do?) bracelets like the ones Kevin and his friends wore, and vinyl wristbands embossed with the phrase "Strength and Honor."

The Kevin Thomas Neff Memorial Scholarship was established in 2004 by Robert and Rebecca Marley. It has grown to over \$14,000 through numerous donations. The fund is also supported by the annual Kevin Neff Memorial Volleyball Tournament, held at St. Hilary School under the direction of St. Hilary physical education teacher, Tami Stamets. This year's tournament was held May 22, and raised over \$1,000, according to Mrs. Stamets. About 175 students and adults participated. The Neff family operated a concession stand and played in the tournament, wearing T-shirts emblazoned with Kevin's motto, "Strength and Honor."
